



Wir haben jetzt einige Code und die 777 Morningstar Foundation, welche zum Königreich Kingdom Filipina Hacienda gehört.


Wie setzen sich die Puzzles zusammen?






Landbesitzurkunde **Nr. T-01-4** Hacienda Filipina

Zhou Enlai to secure sums, producing in the addendum aggregate and of the effective sum to backup the Chinese legal tender equivalent of thousand of Metric Tons of Gold (Au) and United States Dollar in mark of Wells Fargo, Red Seal, Green Seal 1928 and 1934 Series with 2 1/2 percent per annum.

These present entered into TVM-LSM-666 between the Government of Peoples Republic of China represented by its First Prime Minister Hon. Zhou Enlai for the Bank of China and other subsidiary banks up to Hongkong. Case No. 572 of the Royal Audiencia, having been duly and regularly heard in accordance with the Provision of the Land Laws as adopted order Torrens System, it is hereby decreed that Prince Lacan Acuña (formerly Taguean Clan), married with Princess Rowena Ma. Elizabeth Overbeck Macleod of Austria, the owner in Fee simple of certain lands, known as HACIENDA FILIPINA, embracing four (4) major Islands, bounded and described as follows:

A parcel of lands (**HACIENDA FILIPINA**) situated and embracing the Islands of Luzon, Islands of Palawan Peninsula, Islands of Visayas and Islands of Mindanao, consisting around 7,169 Island and Islets with a total territorial area of 1,049,212,962 square nautical miles, scating on the Western rim of Pacific Ocean, North of Equator and about 700 kilometers from the Asian Mainland, it is dispersed over a distance of 1,965 kilometers from North to South and 865 kilometers from East to West, bounded on the East by the Pacific Ocean, on the West by the South China Sea, on the North by the Boshi Channel and on the South by the Celebes Sea and the Southern Borneo, consisting 169,972,500 hectares of the plains, mountains, forest and seas, more or less, it embraced four (4) major Islands described as follows:

Islands of Luzon embracing the area of Luzon Region, Abra, Apayao, Benguet, Ifugao, Kalinga, Mountain Province, Ilocos Sur, La Union, Pangasinan, Batanes, Cagayan, Isabela, Nueva Viscaya, Cabarroquiz, Province of Manila, Bulacan, Zambales, Pampanga, Tarlac, Morong, Lake Province, Bumbon Province, Kawit Province, Marinduque Province, Mindoro, Karilaya, containing an area of **31,804,624 hectares** more or less.

II. Islands of Palawan, Peninsula Region, embracing the area of Albay, Camarines (Ambos Camarino Sur con Norte), Masbate, Sorsogon, Palawan and Spratley Islands, containing an area of **3,652,875 hectares** more or less;

III. Island of Visayas Peninsula embracing the area of Iloilo, Aklan, Romblon, Antique, Capiz del Romblon, Guimaras del Iloilo, Negros Occidental de Buglas, Negros del Oriental, Siquijor de Bohol, Cebu, Leyte, Biliran de Leyte, Leyte del Sur, Leyte del Norte, Cibabao del Samar, Cibebao Este, Cibabao Norte,

however, to such of the requirements and encumbrances prescribed by Escribania de
Cabildo and the Laws of the Council of the Indies as may be subsisting to
Witness, His Highness King George III of the Royal Crown of England,
the seventeenth day of January, Seventeen Hundred and Sixty Four.

THE PHILIPPINES

In the Spanish American War period, United States Military Government (USMG) in the Philippines began on August 14, 1898, with the surrender of Spanish troops. The Treaty of Peace between the United States and Spain (Treaty of Paris) was signed on December 10, 1898, and came into force April 11, 1899. Article 3 specified: "Spain cedes to the United States the archipelago known as the Philippine Islands" In the peace treaty, Spain ceded the Philippines, and the United States was designated as the receiving country. In reality, the transfer of the sovereignty of the Philippines from Spain to the United States was conducted through USMG. This can be explained as follows:

Action Result

1. Spain has ceded the Philippines in the peace treaty. In effect, upon the date of cession, Spain has ceded the Philippines to the USMG, and this is an interim status condition.
2. With Spain's consent, the peace treaty has specified the importantly, upon the date of cession, under international law, an authorized civil
3. United States as the "receiving country," for the cession, government for the Philippines, to whom the (principal) occupying power can relinquish the territory, does not yet exist. However, the Philippines has been ceded to the USA in the treaty, hence the United States Congress is authorized to pass relevant legislation to establish a civil government for the Philippines.
Comments: Under USMG, the United States flag flew over the Philippines from August 14, 1898, until July 4, 1901. During this period, the allegiance of the local populace was to the United States. Since The Philippines was ceded to the USA in the post-war peace treaty, the United States flag continued to fly after the establishment of civil government operations in the territory. The populace continued to give allegiance to the United States. It is important to recognize that under the military government of the (principal) occupying power, the Philippines had not yet reached a final political status. During this period, the Philippines was in "interim status" under the law of occupation. This "interim status" condition continued until the military government of the (principal) occupying power was legally supplanted.
